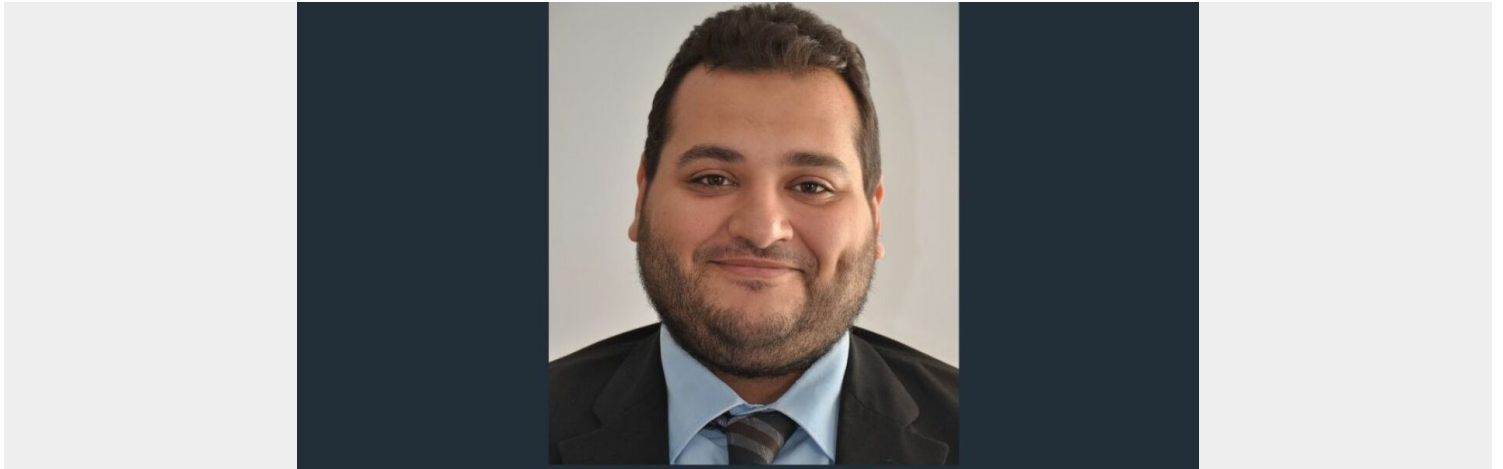


# NOUR EL-HAJJAJI: A TRIBUTE TO MENTOR AND ADVOCATE FOR JUSTICE
